LIABILITY WAIVER

In consideration of being permitted to enter for any purpose any RESTRICTED AREA(S) (herein defined as Including, but not limited to the racing surface, pit areas, infield, hot pit, and all walkways concession, and other areas appurtenant to any area where any activity related to the event shall take place, THE UNDERSIGNED for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering upon such RESTRICTED AREA(S), and will continuously thereafter inspect such RESTRICTED AREA(S) and all portions thereof with which he enters and comes in contact and he does further warrant that his entry upon such RESTRICTED AREA(S), and his participation, if any, in the event constitutes an acknowledgement that he has inspected such RESTRICTED AREA and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if at any time, he is in or about restricted areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the RESTRICTED AREA(S);

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoter, participants, school, association, agents, sanctioning organization and any subdivision thereof, track operator, track owner, officials, vehicle owners, drivers pit crew, any persons in any RESTRICTED AREA, promoters, sponsors, advertisers, owners and lessees, of the premises used to conduct the event and each of them, their officials, employees, and agents for all purposes herein after referred to as "OFFICIALS", from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin for any and all loss, for all loss or damage and any claim or demands therefor on account of injury to that person or property, or resulting in death of the undersigned whether caused by the negligence of the OFFICIALS or otherwise, while the undersigned is in or upon the RESTRICTED AREA and/or attending class, officiating in, observing, working for, or for any purposes participating in the event.

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the OFFICIALS and each of them for any loss or liability damage or cost they may incur due to the presence of the undersigned in or upon the restricted area, or in anyway competing officiating observing or working for or for any purpose participating in the event and whether caused by the negligence of the OFFICIALS or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, due to the negligence of OFFICIALS or otherwise, while in or upon the RESTRICTED AREA, and/or while attending, officiating, observing or working, or for any purpose participating in the event.

THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are dangerous and involve the risk of serious Injury and/or death, and/or property damage.

THE UNDERSIGNED further expressly agrees that the foregoing Release Waiver and Indemnity Agreement is Intended to be as broad and inclusive as is permitted by the law of the province or state in which the event is conducted in that if any portion thereof is held invalid, it is agreed that the balance of the agreement shall remain valid, legal and enforceable.
